BUDGET VOTE/TRUSTEE ELECTION RESULTS

RESOLUTION#052-22

At a duly called meeting of the Board of Trustees of the Mount Vernon Public Library, upon a motion made by H. MARABCE, and seconded by O. DAVIS the following resolution was adopted:

WHEREAS, the Board of Trustees is authorized by the Education Law to place elections and/or propositions on the ballot of a district meeting of the Mount Vernon City School District to ask the voters to vote on the election of Library Trustees and a tax levy to support the operations of the Library, and

WHEREAS, one vacancy exists for the office of Trustee of the Mount Vernon Public Library for the remaining balance of a five-year term, expiring June 30, 2025, created by the resignation of Trustee Cathlin Gleason, and

WHEREAS, one seat on the Mount Vernon Public Library's Board of Trustees will become vacant after June 30, 2022 with the end of the term of Vivien Salmon, and a new Trustee needs to be elected to fill a five-year term expiring on June 30, 2027, and

WHEREAS, the Library Board of Trustees voted to seek a tax levy increase of \$265,063 or 5.25% from taxpayers for a budget total of \$5,044,157 for the library's 2022-2023 fiscal year, and

WHEREAS, on May 17, 2022, an election was conducted by the Mount Vernon City School District on behalf of the Mount Vernon Public Library on the proposed budget increase and to fill two Trustee seats on the library's Board of Trustees, and

WHEREAS, on May 17, 2022, the voters of the Mount Vernon City School District disapproved a proposed tax levy to support the operating budget of the Library submitted to them by the Library's Board of Trustees in a vote on the following question:

PROPOSITION #2 – Resolved: That the 2022-2023 General Fund Budget hereby adopted for the appropriation of the necessary funds to meet the estimated expenditures be approved and that the Mount Vernon Library Trustees of the City of Mount Vernon, Westchester County, New York, authorized to expend an amount not to exceed \$5,044,157 for General Fund purposes and to levy the tax necessary therefore.

and

WHEREAS, on that same date and time, the voters of the Mount Vernon City School District elected two Trustees, one for a term of 5 years ending June 30, 2027, and one for the remaining term balance of 3 years ending June 30, 2025, created by Trustee Cathlin Gleason's resignation

and

WHEREAS, Alice Patterson, the Senior Clerk and Records Access Officer of the Mount Vernon City School District has certified the tally for the May 17, 2022 vote (copy attached).

NOW therefore be it

RESOLVED that the Board of Trustees hereby declares the results of the May 17, 2022 Budget Vote/Trustee Election as set forth on the attached tally sheet. In accordance with these results, the Board of Trustees hereby declares that the budget (Proposition #2) was not approved; and that Vivien Salmon has been elected to serve on the Board of Trustees for a five-year term beginning on July 1, 2022 and expiring on June 30, 2027; and Chanese V. Coleman has been elected to serve on the Board of Trustees for the remaining term balance of three years (beginning on May 18, 2022 and expiring on June 30, 2025), created by Trustee Cathlin Gleason's resignation.
