## A RESOLUTION TO APPROVE THE SEARCH FIRM HIRED TO COMPLETE THE LIBRARY DIRECTOR SEARCH

**WHEREAS**, the Board of Trustees for the Mount Vernon Public Library authorizes by this resolution to hire The Burgess Group, Corporate Recruiters International, Inc. for the assignment of recruiting a Library Director.

*WHEREAS*, the Burgess group has reviewed the Job Description specifications and understands the scope of work required to recruit this senior level position of Library Director for the Central Public Library of Mt. Vernon.

**WHEREAS**, the Burgess Group will introduce benchmark candidates within thirty (30) days or sooner, all searches will be completed in 45-60 days.

**WHEREAS**, the Burgess Group will guarantee a candidate for one (1) year and for any reason the client terminates the finalist, the Burgess Group will replace him/ her at no cost to the client; except for the monthly office expenses not to exceed \$300 per month until a replacement has been hired.

**WHEREAS**, management consulting services charges \$15,000 to prepare search plan, source, identify, advertise, evaluate, interview prospective candidates and prepare potential candidates' Executive Briefs to recruit the Library Director

**WHEREAS**, an additional cost of 15,000 for services for presentation of candidates, interview arrangements and coordination, reference checks and compensation negotiations to recruit the Library
