A RESOLUTION TO APPROVE THE MEMORANDUM OF UNDERSTANDING BETWEEN THE BOARD OF TRUSTEES OF THE MOUNT VERNON PUBLIC LIBRARY & CIVIL SERVICES EMPLOYEES ASSOCIATION, INC., LOCAL 1000, AFSCME, AFL CIO,

**WHEREAS**, the Board of Trustees of the Mount Vernon Public Library has entered into negotiations with the Civil Services Employees Association, Inc., Local 1000, AFSCME, AFL CIO, the Mount Vernon Library Unit 9166-01, in regards to a Collective Bargaining Agreement which expired on December 31, 2013 ("Expired CBA");

**WHEREAS**, the parties have now reached an agreement as of the date of execution of a Memorandum of Agreement on the terms and conditions for a successor collective bargaining agreement for the period of January 1, 2014 to June 30, 2024 ("Successor CBA"), and have to memorialized their understanding, in writing, pending the signing of the Successor CBA;

**WHEREAS,** Board of Trustees for the Mount Vernon Public Library, have to approve this Memorandum of Agreement on the terms and conditions for a successor collective bargaining agreement for the period of January 1, 2014 to June 30, 2024 ("Successor CBA"),

#### **NOW, THEREFORE,** be it

**RESOLVED**, that the Board of Trustees for the Mount Vernon Public Library has approved, adopted and authorized the acceptance of the Memorandum of Agreement on the terms and conditions for a successor collective bargaining agreement for the period of January 1, 2014 to June 30, 2024 ("Successor CBA") with the Civil Services Employees Association, Inc., Local 1000, AFSCME, AFL CIO, the Mount Vernon Library Unit 9166-01.

Upon a motion made by Cathlin Gleason, seconded by Malcolm Clark, the Board approved and adopted Resolution #0152-19. The vote carried 4 yes and 0 no.

The Trustees of the Board made statements that they wanted to state for the record.

<u>President Davis:</u> stated for the record, we have made improvement for the infrastructure of the library. This is the 1st elected board to complete a contract, a 10 year contract, this is really a plus for the staff. I would like to congradulate everyone that was involved. **Trustee Gleason:** One of the best aspects is that we are moving forward and it's a plus for the employees, this has been a labor of love. This is a fair contract.
